### GENERAL CLASS INFORMATION

The studio reserves the right to substitute a qualified teacher when the assigned teacher is unavailable. Classes must have a minimum enrollment of 6 students. We will advise students of alternate classes if a class is cancelled due to enrollment.

### DROP OFF AND PICK UP

Initial \_\_\_\_\_

When you drop your child off at the studio please be sure they have safely entered the building before you leave. After a dancers' scheduled class ends they need to be picked up, or be under adult supervision. If this does not happen you will be charged \$1 per minute until the child is under adult supervision or is picked up. Children **CAN NOT** wait in the parking lot for their parents, family, or friends. While in the studio, students and siblings must be supervised at all times: no running, throwing pillows, jumping on furniture, etc!

### DROPPING ENROLLMENT

**If you would like to drop a class or drop enrollment completely, you must provide 30 days written notice (Must be done on the first of each month with payment for your final month— cannot drop classes mid month).** A drop slip is provided in the office for this purpose. Tuition will continue to be charged to your account until we receive this formal notification. Please note that if you drop completely from the program, you will have to pay the registration fee to begin again. This does not apply to TEAMS – see Team Contract for drop policies.

### ANNUAL EVENTS

#### ANNUAL SHOWCASE

There will be an annual showcase held in **July**. General participation is optional. The exact date will be announced closer to the event. Costumes will be approximately **\$90**. The first deposit of **\$60.00** for the costumes is due **March 30, 2014**. The balance is due **June 15, 2014**. There will be a **\$10** late fee if these monies are not remitted by the above-referenced dates. For the annual showcase it is **mandatory** for each family to purchase **4 tickets** in order to be able to participate.

#### STUDIO CLOSURE

Studio will be closed for Christmas Break, Spring Break, Memorial Day, 4<sup>th</sup> of July, end of season break usually last week of Aug-first week of Sept, 2 weeks total. Tuition is based of 4 classes per month and the Holiday classes are made up throughout the year by the months that have additional days plus extra rehearsals, shows, & activities.

#### COMPANY AUDITIONS

Competition Team, Show Team and Professional Company auditions are held each August. L.A. Hip Kids and L.A. Teen Scene auditions are held each January. Hollywood Launch auditions are held in June and Dec.

**TUITION – Checks To Be Made Payable to The Rage :** Tuition is due by the 1<sup>st</sup> of the month. If received between the 6<sup>th</sup> and 10<sup>th</sup>, the late fee is \$10.00; between the 11<sup>th</sup> and 15<sup>th</sup>, the late fee is \$15.00; between the 16<sup>th</sup> and the 20<sup>th</sup>, the late fee is \$20.00; between the 21<sup>st</sup> and the 25<sup>th</sup>, the late fee is \$25.00, and if paid between the 26<sup>th</sup> and the 30<sup>th</sup>, the late fee is \$30.00. There are no exceptions due to student being out of town or studio closure.

Payments can be placed in the tuition box located outside of the office or mailed directly to **Veda Burton, at 16909 Devonshire Blvd, Granada Hills, CA 91344.** MAKE SURE you put the student’s name along with what you are paying for on either the check or the envelope. If payment is not received by the 1<sup>st</sup> of the following month an additional 10% interest charge will be added to your account. No statements will be sent. Your cancelled check is your receipt. There will be a \$25 returned check fee. You will receive a receipt for cash payments. We also accept Visa, Mastercard, checks, cash, and can be enrolled in Auto Pay.
